#### Ralston Creek Streetscape at Corners Α.

Maureen Phair provided a historical summary of the project. This project is limited to the corners at USBank and KFC/Taco Bell. She introduced Mike Beech with RidgeTop Engineering. RidgeTop Engineering issued an RFP for construction of the corners. The total bid for construction, signs, and underground utilities is \$912,213. Ms. Phair asked approval from the AURA Board to sign the contract with authorization to approve change orders up to \$950,000.

Additional clarification on the project cost was given by RidgeTop including the constraints and availability of contractors and subcontractors.

Commissioner Williams moved that the Arvada Urban Renewal Authority Board of Commissioners approve the investment of up to \$950,000 for contracts required to construct the Ralston Creek streetscape improvements at the southeast corner of Ralston Road and Independence Street and the southwest corner of Ralston Road and Garrison Street.

### 9. New Business

### A. Maureen Phair's Annual Review Preparation

Vice Chair Parker and Commissioner Bolin summarized the research and development of Maureen Phair's revised job description and evaluation of performance form.

Carrie Briscoe was tasked to transform review form into either a PDF or Google Form that can be easily completed by all members of the AURA Board. Carrie Briscoe will finalize form and send to Chair Parker by September 16, 2016. Chair Parker will distribute to Board with all responses due by September 23, 2016. The results of Maureen Phair's performance review will be held in the October 5, 2016, executive session.

### 10. Development Update

Walmart – Building shell and roof is nearly complete, and site and utility work continue.

Solana – City agreed to assist with a portion of the extra cost to construct the pedestrian crossing at Saulsbury. Curb, gutter, and road are installed. Framing and vertical construction has begun. AURA is not participating in the funds required for the pedestrian crossing.

Ralston Creek –

Phase 1: Safeway demolition is complete. There has been a lot of coordination with CDPHE and Xcel. The Ace Check Cashing building is abated. There is leasing interest with an LOI expected from a restaurant. There is a utility easement that runs diagonally through the Independence Center site. The easement includes a concrete vault and fiber. The proposed building three is placed directly on top of the concrete vault. The location of the vault and fiber and their effect on the construction of building three is to be determined.

Phase 2: Arvada Square Stipulation Agreement was signed with the court issuing a final rule and order. AURA holds title to Arvada Square.

9-acre Site – Trammell Crow will hold a neighborhood meeting in September or October 2016. Trammell Crow has been able to re-engage the grocery store. They are in discussion with the grocery store to determine if the site plan will work for the size of the store they require.

Hilton – There is significant progress with construction reaching the fifth floor and installation of windows. They have estimated a March or April 2017 completion.

She will be working on the City's Attainable Housing Committee along with Carrie Briscoe and other City management to educate City Council on various affordable housing developments, data, barriers, etc.

She reported on the various meetings and conferences she attended during August 2016.
