#### 10. Development Update

RTD G-Line - Maureen Phair provided an update on the opening of the RTD G-Line. There is no word from RTD concerning the delay. However, the FRA has given RTD a 90-day extension on the A-Line. Commissioner Williams added that RTD will know by Friday, November 4, 2016 whether or not they can resume testing on the G-Line.

Walmart – The building shell and roof are complete.

Ralston Creek North – Phase 1: Maureen Phair announced that the Big O, Gloria's, and Triangle Liquor buildings have been demolished. The developer is still working on leasing. Phase 2: The

developer needs a partner that would help bolster the development's ability to get financing. The commercial finance market has been tightening, edging out smaller developers. She also explained that the AURA Board will have to approve the partnership and amendment to the DDA.

Solana – Construction is moving right along with the clubhouse taking shape. The linear park to the north of the site is nearing completion. Additionally, the Solana development in Boulder sold recently for \$136,000,000 or \$426,000 per unit. This is the second highest multi-family sale in Boulder.

9-acre Site – AURA Staff met with Trammell Crow and the architect on November 1, 2016. They are hoping to get their PDP submittal into the City by the end of the month. They are currently focusing on the building façade renderings. Entitlements will take nine months to one year. Their financing is strong since they are part of CBRE.

Hilton Garden Inn – The stone façade has been installed. They have dry-walled three floors. Construction should be complete by January 2017. The FF&E contractor will take over for an opening in March 2017.

Arvada Ridge Phase 3: The developer is hoping to break ground Spring 2017. Commissioner DeLaria asked if they will experience similar financing challenges as the Ralston Creek Phase 2 multi-family. Maureen Phair has not heard of any problems, but that they are partnered with Embry.

#### 12. Comments from Commissioners

Treasurer Cline asked about the opening of the Olde Town Arvada parking garage and whether the opening of the garage would be tied to the opening of the G-Line. Commissioner Williams and Maureen Phair said they are not tied together and that the garage should be open by the end of November 2016. Mike Polk added that the City is working with RTD on a parking monitoring system.

Commissioner DeLaria commented on the progress at the Ralston Creek North development. She also asked about what was happening with the Roadie's shop in Olde Town. It will be a new Coors Credit Union branch.

Commissioner Piz Wilson commented that the RTD G-Line landscaping upgrades near her business have inspired her to re-do the landscaping at her business.

Commissioner Williams spoke with Bill Mosier of Trammell Crow recently. Trammell Crow seems to have a very positive outlook on the 9-acre development site. Additionally, the Marketplace at 52<sup>nd</sup> and Wadsworth Boulevard has started remodeling the buildings and site.

Vice Chair Parker commented that the business outlook in Arvada is very positive with projected growth.
